1. Introduction

The Child Parent Institute (CPI) is seeking qualified subcontractors to provide solar installation and related energy system upgrades for the development of a Community Resilience Center (CRC) located at 3650 & 3642 Standish Avenue, Santa Rosa, CA 95407. The purpose of the CRC is to ensure uninterrupted access to essential services during emergencies and promote long-term energy resilience for the surrounding community. We invite experienced and licensed firms to submit a proposal in response to this Request for Proposals (RFP)

2. Scope of Work

The selected subcontractor will be responsible for the following tasks:

Task 1: Solar PV Installation

Design and install an 183 kW rooftop solar photovoltaic system, including all necessary mounting structures, inverters, and interconnection equipment.

Task 2: Battery Energy Storage System (BESS)

Provide and install a 1 MWh battery energy storage system to support the solar PV system, including integration into the facility's energy management system.

Task 3: Electrical Utility Upgrade

Upgrade the electrical utility service, including installation of a new electrical panel in accordance with project specifications and local utility requirements.

Task 4: Rewire for Heat Pump Systems

Reconfigure and upgrade electrical infrastructure to support the installation of energy-efficient heat pump HVAC systems.



Task 5: Underground PG&E Coordination

Install and/or coordinate underground utility connections with PG&E, including trenching, conduit installation, and necessary inspections.

Task 6: Labor, Materials, and Equipment

Provide all labor, materials, equipment, and tools required to complete the above scope of work.

Task 7: Code Compliance and Permitting

Ensure all work is performed in compliance with local, state, and federal codes, including securing necessary permits and inspections.

3. Proposal Requirements

Company Profile

A brief background of your company, including years in operation, services provided, and any relevant project experience.

Licensing and Certifications

Documentation of all applicable contractor licenses, OSHA certifications, and specialized credentials relevant to energy and electrical work.

Prevailing Wage Compliance Statement

All contractors must adhere to all prevailing wage requirements under California law, including the submission of all necessary documentation to demonstrate compliance with applicable labor standards. As this is a state-funded public works project, all contractors must adhere to the California Labor Code which requires payment of local prevailing wages to workers and laborers on state government contracts.

Project Approach and Timeline

A clear outline of your proposed project methodology, phasing, and estimated schedule for completion.

Detailed Cost Estimate

A comprehensive breakdown of all costs, including labor, materials, equipment, overhead, and contingencies.
