Job Title: Bilingual Trainer, Parent Orientation to Child Welfare Services Program

Job Classification: Full-Time, Non-Exempt

Reports to: Deputy Director

Hours: 30-40 per week including some evenings and weekends

JOB SUMMARY: This position provides individual support and group training to parents who are involved in the Child Welfare and Dependency Court Systems. The Bilingual Trainer is also responsible for direct outreach to parents and to other community programs that parents may interact with.

ESSENTIAL FUNCTIONS:

- Contact parents directly to engage them in the program.
- Conduct regular group sessions in a classroom setting to teach parents about the Child Welfare System, Dependency Court, Foster Care and Family Reunification as well as skill building exercises in self-regulation, communication, and follow through on case plans.
- Work closely with Sonoma County Family Youth and Children's Services to understand how the Child Welfare System works, the goals of Team Decision Making Meetings and the use of the Juvenile Dependency Court system.
- Coordinate guest speakers for class sessions and arrange for interpretation services if needed.
- Develop knowledge about community resources.
- Contact other community organizations serving parents to educate them about the Orientation program.
- Document all contacts with families including class attendance, individual sessions and phone contact
- Coordinate all logistics including printing class materials, making room reservations, providing snacks, etc.
- Attend required individual supervision meetings as established.
- Complete all scheduled program reports.

KNOWLEDGE/SKILLS/EXPERIENCE:

- High level of proficiency in developing and presenting training materials.
- Knowledge of the Child Welfare System, Dependency Court, Foster Care, and Family Reunification.
- Knowledge and experience in working with diverse populations, utilizing culturally competent, strength-based strategies.
